

Thank you so very much for your reply. You could never know how deeply I am moved by just you reading my situation. This I can tell you, I am up against so very big people in society- I'm talking about the police dept, the schooldistrict, DSS, and even as high up as the governer's office. I tried writing so many people including the Montel show. I even contacted the FBI; I spoke to Mr. Sameul Self. At first he appeared like he wanted to help, but then her told me to be patience eventually I'll get my kids back. Then he started asking me question like how do I dress and how much make-up that I wear. But just like others who have attempted; they become intimidated for some reason or another and back down. Please except my thank-you and gratitude in advance. If it comes to the point that you cannot help me. I just appreciate your willingness to listen.

My daughter that was raped she is now 6 years old. She remembers bits and pieces a lot of times she talks about it about she sees a commercial about Chucky Cheese's (one of places she and her sister was taken too.) I gave you a brief piece of the story, unfortunately it is very long and in depth. My then seven year old daughter is the one that told me what happened. She said that she heard her sister screaming from her classroom; so she asked her teacher to leave to check in on her. When she did, she said that my daughter's shorts were down and a white boy was putting a pencil in her pee-pee. There were two tan boys kissing her and one black boy shaking on top of her. (The five year old) She said when she walked into the classroom the one of the teachers that was present said, "Shut-up you brat, cause she needed to have it done to her anyway!" At that time another teacher walked in; she and my seven year old took the boys off top of the five year old. My seven year old was then made to take her into the bathroom and clean up the blood from her legs. This is where things really start getting weird. She said that they went into the lunchroom and one of the lunch lady's offered her little sister some candy. They told her no. But the candy was forced on her anyway. But before she was made to eat the candy; she said that two other boys ate the candy and supposedly they died. I know that this couldn't be true, but I do believe that this was some type of role play used to intimidate the children into not telling their parents. She then said that they were made to sit in the principal's office there someone who was a woman in a big van picked them up and carried them to a woman's house they were able to describe the house in great detail. They took off my daughter's clothes and attempted to wash the blood stains from her clothes. They went to the zoo, Carmax (an auto-dealership), and Chucky Cheese's. When I asked my daughter what they did at Carmax. She said, "Mommy we ran around some Honda's, played a fighting video game, colored, and played with dolls." I went there to investigate since it appeared the police would not. I went there and a young lady by the name of Karen Carter saw my girls. I have our conversation on tape. Two days after I talked to her she never returned back to work. My daughter also said that they were taken to Ms. Lee's office. She said that they got shots in their arms and behind their legs; the room began to spin. "Narcotic" She said that returned back to the lady's house to put back on her sister's clothes. They were then taken back to school. But when they got on the bus some boy kicked my daughter in the face; she began to bleed from her nose and her (pee-pee). They took them to office and made them wait until all the other bus left. They were taken to a different house this time. They attempted to wash her clothes again. But they didn't have enough time to dry them. When I touched her clothes; they were damp and smell fresh as if they were just washed.

. I beg the police to retrieve the video surveillance tape from Carmax, but they refused. They said that there was no case. But ten days after, my daughter talked to the criminal investigator. DSS came and removed all four of my children from my home. Even my three year old twin boys, who were not involved. When we went to court my husband nor I were allowed to testify. They cut-out portions of my hair and my daughter's hair. Nothing was founded. My children were in foster care for ten days. The judge said that I was too overly zealous to find the truth. But in the same voice said I did everything I was suppose to and if I didn't I would be neglecting my children. After ten days, my children remained in the custody of my brother and sister-in-law. The reason being I was told to undergo psychological testing. I took a 500 question test, by a licensed counselor not a Dr. He and I spoke for about 45 minutes. His report said that I showed possibly symptoms of narcissism and paranoia. After his report. I was then sent to a doctor and another licensed counselor and they said nothing was founded. Still after that, my children was kept from me. The DSS investigator that cause all of this her name was Katheryn Merryfield. Unfortunately, she died just two Sundays ago. One of the Guardian Ad Litem's is no longer working for them and the counselor that was assigned to my daughter. After she attempted to help me and the show, "48 hrs" she was no longer heard of again. One week before my son's were returned to me; the Guardian Ad Litem called it was Teresa Webber she apologize for what my family underwent. She said that she only done it because of the report from DSS. Three weeks before Christmas, my girls were returned. The reason, I'm seeking your help is because I need someone honest and from the outside to help my family. Also those little boys and those adults are still out there, what happened to my girls was there first time and I believe in my heart that it wouldn't be the last. Those boys and there parents need help also. Anything that you can do to help, would be so greatly appreciated.
